

**Action Required:**

Providers with MSSP patient attribution are strongly encouraged to begin scheduling **Annual Wellness Visits (AWV)** in 2023.

Please review details below:

The AWV is the most important method for influencing risk adjustment, attribution capture, closure of care gaps, and retention of beneficiaries for the Medicare Shared Savings Program (MSSP). Risk adjustment greatly contributes to the amount of shared savings or shared losses. Attribution capture contributes to maintaining a strong Qualifying Participant (QP) score to achieve the annual 5% APM bonus distributed to all Scripps ACO MSSP participants.

The best time to conduct the AWV is within the first part of the calendar year when possible. Medicare covers an AWV for beneficiaries who have met the following criteria:

- Are not within 12 months of the effective date of their first Medicare Part B coverage period
- Have not received an Initial Preventive Physical Examination (IPPE) or AWV within the past 12 months

Additional benefits from the AWV are:

- Identifies current health and risk factors with the health risk assessment (HRA) and supports quality metrics
- Ensures accurate documentation of patient risk levels through HCC coding
- Provides an opportunity to review patient's care plan
- Diminishes potential for patients to be cost outliers

An AWV may be performed by any of the following providers:

- Physician (MD or DO)
- Qualified non-physician practitioner (PA, NP, CNS)
- Medical professional(s) who are directly supervised by a physician

As a reminder, an attributed beneficiary is assigned by identifying the provider's NPI that provided the past year's most primary care-based services. If you are a provider with attributed beneficiaries but do not conduct AWVs, it is extremely important to refer the beneficiary back to their PCP to complete their AWV as soon as possible within the criteria timeframe.
